Dear friends,

Indian Council of Food and Agriculture is working as the apex policy think tank, trade facilitation body and development enterprise for food and agriculture sector in India and serving as global platform for partnerships. With the increasing globalization, there are newer challenges emerging, which need to be proactively addressed for India's Food and Agriculture sector to grow, engage and compete globally and contribute towards food and nutritional security. ICFA through its outreach policy and business agenda and global partnerships is creating opportunities for growth, value addition and trade to help improve the income of farmers. ICFA has taken up agriculture stewardship and national certification program, focussing especially on the agriculture produce meant for nutrition and health sectors, retail and processing purpose and for exports. ICFA is also promoting investments, entrepreneurships and technologies in farm sector by forging global partnerships with right institutions and by taking up projects, training and facilitating farmers producer organizations and agri start-up ventures to accelerate growth in farmers incomes, productivity and agribusinesses.

With rapidly expanding opportunities in Indian food and agriculture sector and its growth story in the last one decade, there is increased interest among the major countries of the World to engage with India and explore opportunities for investments, trade and cooperation. There has been long felt need for a dedicated body to facilitate such engagements through Joint Business Councils with various countries while promoting agri-produce from Indian States and guiding them on investments, marketing and policy issues. India also needs institutional mechanism at the States and district levels, wherein various stakeholders could meet and deliberate upon issues and agenda to unleash the potential of agriculture. ICFA promises to provide that mechanism through services platforms, and state and district chapters.

COMPANY OVERVIEW

Indian Council of Food and Agriculture was established in the year 2015 backed with a thought process of over 12 years. Given the importance of agriculture in Indian economy as still 50 % of country's population is directly dependent on farm sector for its livelihood and sustenance and the rapid transformation of agriculture throughout the globe and especially developing countries, changing the course of global food and agriculture trade, the council was constituted to represent Indian Agriculture sector globally and take up issues at the national as well as international level.

ICFA is an apex body, which act as a think tank, information bank, advocacy group, watch-dog, development catalyst, trade, technology and investments facilitator and monitoring center for food and agriculture sector at national and global level. It acts parallel to trade bodies like CII, FICCI etc., but is different from them in scope and objectives to represent not only the interests of the industry but also the sector as a whole, including the farming community.

The fast changing trade and economic environment globally requires a paradigm shift in our approach. We have to act proactively and respond positively to the changing dynamics of the global trade and agriculture. The bench-marks are now global and we have to prepare our policies and strategies with global perspective. Though the country has become self reliant in food grains production, its average productivity and quality is low and the cost of production high, which makes Indian agriculture less competitive in the world market. Therefore, there is need for global cooperation in agriculture and much greater need for boosting up trade in food and agriculture. This sector also promises great potential for start-up ventures and entrepreneurship opportunities, which ICFA facilitates.

A paradigm shift is required in our approach to agriculture; from production to marketing, from quantity to quality and domestic to international consumers. Agriculture has to be practiced on scientific lines with the use of best of technologies available to compete globally in cost and quality. A major program on crops shifting has to be implemented, taking in view the global benchmarking and our core competitive strengths in various crops. The importance of internal reforms and direction to the sector is enhanced on account of centrality of food and agriculture in the global trade post WTO.

In the changing global agriculture scenario due to increasing pressure to feed increasing population with shrinking resources in a sustainable manner to retain ecological balance and mitigate the effect of climate change, ICFA envisages to play an important role by making agriculture sustainable and profitable.

- To create awareness and understanding on major issues in food and agriculture sector and promote cooperation among the major stakeholders by organizing business meets and consultations; and promote innovations and adoption of successful farming and agribusiness models on larger scale and facilitate visits of trade and official delegations between India and other countries
- To be the national platform for farmers' services, and to execute agricultural projects, entrepreneurship programs and farming ventures; and forging linkages with the industry, institutions and development bodies to promote commodity specific professional groups; and to act as apex facilitation body to further the cause of farmers and key stakeholders involved in food, agriculture and agribusinesses.

ICFA WORKING AREAS

Indian Council of Food and Agriculture, being the first think tank in the sector of food and agriculture in India focuses on almost all aspects of the agricultural sector of India from farmers to the industry. With this wide view, the council focuses on the following working areas by conducting RTCs, launching Working Groups with respect to various sectors and signing MoUs with various institutes.

- 1. **Policy Research and Advocacy:** The success of farming or the businesses depend upon the policies of the Governments, which regulate markets, pricing of inputs and outputs and almost everything in the environment in which agriculture and food sector operate.
- 2. **Global Platform for Partnerships:** With the globalization of trade and economies, and the issue of climate change emerging as major global concern, there is need for collective efforts and cooperation towards achieving food security and environmental sustainability.
- 3. **Trade and Agribusiness Facilitation:** India has got very large and diverse food production system, growing almost every crop and every animal that is grown in any part of the world. However, share of India in global food and agriculture trade is minimal, which ICFA promises to boost.
- 4. **Startup Ventures and Projects Consulting:** Indian agriculture promises enormous opportunities for entrepreneurships development and start-up ventures and agriculture and food value chain, but there is need for effective facilitation and quality projects consulting for best results.
- 5. **Agri Services and Farmer's Empowerment:** Indian agriculture lacks professional services right from farm management and agribusinesses to delivery of programs and schemes and connecting farmers with the markets and technologies and ICFA is committed to address that need.

6. **Food Safety and Agriculture Stewardship:** Access to safe, nutritious and healthy food is a fundamental right of the people. However, a vast population globally is suffering from malnutrition and unsafe food. Towards this end, ICFA has launched GAP Project and Healthy Food Initiative.

ACTIVITIES UNDERTAKEN

Working Groups, Councils and Alliances

Indian food and agribusiness industry is large and diverse with about a dozen industries offering inputs for agriculture and about three dozen industries involved in output businesses and agri-food value chain. Each major industry has its one or more national level associations, catering to the policy and development needs of that industry. However, need has been felt for a long time to have larger support system to substantiate efforts of each industry with more research and knowledge inputs and institutional, policy and political support system. With this vision, ICFA has institutionalized sector specific working groups, councils and alliances. Till previous year, ICFA had operationalized eight working Groups and during the period of 2018–19. Also, one state councils, in addition to previous two district councils have been constituted.

Launched India Seed Forum

Date: Sep 18, 2019 Venue: Bangalore



India Seed Forum (ISF) was launched by the Honble Union Minister of State for Agriculture, Mr. Parshottam Rupala at the SeedWorld2019 at Bangalore. The Forum will work on seed production stewardship programs, traceability, GAP Certification, policy advocacy and trade issues, value chain development, exports facilitation and global market access for Indian seeds. Forum had 15 nominated members and 25 more would be nominated to have 40 member forum. The forum would be constituted of 30 members from industry and 10 from other stakeholders.

Round Table Conferences (RTCs)

ICFA initiated a series of round table conferences for all the major sub – sectors and aspects of agricultural sector taking all the stakeholders i.e. government officials, policy makers, corporate heads, heads of academic and research institutions on board with a purpose to create a platform for open discussion about issues and challenges of the sector. RTCs envisage taking up major concerns and bottlenecks for the growth of the sector and coming up with the recommendation to overcome the same. Till last year ICFA has organized 23 Round Table Conferences and two more have been conducted in 2019-20.

Zero Budget Natural Farming

Date: October 1, 2019 Venue: India International Centre, New Delhi



ANNUAL REPORT 2019-20

National Consultation Meet on Zero Budget Natural Farming was held with important representatives from the industry, scientific bodies and farming community joined the discussions to work out common framework for ZBNF. Farmers from states like Telangana, Maharashtra, Himachal, Haryana and UP claimed that their profits have gone up but almost all the eminent scientists and industry CEOs expressed their doubts that there could be farming with zero budget. It was decided that ICFA would create a National Platform for Farmers Innovations and coordinate with research institutions and policy makers for validation of results and processes and recommendations.

Consultation Meeting on Seed Traceability

Date: April 11, 2019 Venue: New Delhi



A consultation meeting on Seeds Traceability, joined by eminent experts, seed and IT industry CEOs, was conducted to discuss prevailing global practices and deliberate upon various cost effective options in Indian context, using IT tools and block chain technology to put in place foolproof system of tracking seeds at all the stages of supply chain so as to ensure seed quality, transparency and accountability of all players. The meeting was convened by Dr. NK Dadlani and chaired by DG, ICFA, Mr. Pravin Srivastava, IAS (retd 1980 batch).

DISCUSSIONS AND INTERACTIONS

Besides Round Tables, ICFA time to time organises other consultation meetings, interactions and discussions to address new issues and challenges. In year 2018-19, similar discussions were conducted:

Michigan State University delegation

Date: March 5, 2019 Venue: New Delhi



A dinner meeting was hosted for the 7 member visiting Michigan State University delegation to India. MSU and ICFA are the Partners in Africa Program under USAID Feed the Future. MSU delegation explored partnership in India for its Borlaug Youth Program. The two sides discussed hosting a joint event on Africa during the World Food Summit at Des Moines, USA in Oct, 2020.

UP State Agriculture Council Meeting

Date: Nov 29, 2019 Venue: Lucknow



A meeting of ICFA- UP State Agricultural Council was chaired by Sh. Alok Ranjan, former Chief Secretary of Uttar Pradesh and co-chaired by Mr. TR Kesavan, Chairman, FICCI National Committee on Agriculture and President, Tractor Manufacturers Association. Over 55 representatives, including Directors of Agri, Horti, AH from the State Government, ICAR system, farmers bodies, development institutions such as NABARD, NHB, Nafed, CIMAP etc and corporate, including ITC, UPL, JISL, DSCL, Bayer, DAL, TAFE, Indogulf, TataTrusts etc. joined the deliberations and finalised the Strategic Action Plan for the State. State President of BKU presented the farmers agenda. Four more districts, Muzaffarnagar, Allahabad, Jalaun and Agra were finalised for launching District Agriculture Councils and pilot testing of ICFA FarmerPlus project.

Consultation Meeting on Asia- Africa Technology and Cooperation

Date: 20-02-2020 Venue: New Delhi



A consultation meeting on on Asia-Africa Technology and Cooperation was organised jointly with African Asian Rural Development Organization (AARDO) to facilitate partnerships among the companies and institutions engaged in agriculture technologies and services. ICFA had signed up MoU with #AARDO in 2016 to launch India Africa Agriculture Partnership Platform to mobilise Indian expertise for African agriculture development.

Consultation meeting on Farm and farmers' Agenda

Date: 12-10-2019 Venue: ICFA HQ, New Delhi



A consultation meeting was hosted with potential partners to discuss the upcoming FarmerPlus project. The project was scheduled to be launched in three districts of Karnal in Haryana, Agra and Lakhimpur in UP in Dec 2019 with 20 industry and institutional partners. The project aims to provide powerful support system to initially 1000 member farmers of ICFA District Agriculture Councils. Prof. A Ginige and Paul Collin from the Western Sydney University, Australia made detailed presentation of their features loaded App, AgriSavvy, which has shown very good results in four States in India. Representatives from Ernst & Young, SourceTrace, Cargill, CropLife India, Sonalika Tractors and others participated in the discussion.

Meeting on farmers' issues and policy push

Date: 20-09-2019 Venue: CM Karnataka Office



A fourteen member delegation of eminent persons met Shri B.S. Yediyurappa and discussed about the farmers issues and the policy push needed to boost the growth of agriculture in the state and especially making the state global hub of seed production. The delegation members also suggested to create an apex body to give boost to agri exports and to agri startups in the state.

ICFA Senior Management

Date: 04-07-2019 Venue: ICFA HQ



ICFA senior management met and discussed the internal survey report on converting the Indian Chamber of Food and Agriculture into a chamber to better focus on global trade and business opportunities for Indian food and agriculture sector and promoting agribusinesses and Startups and value chain development towards linking farmers with the domestic and exports markets and improving the competitiveness of Indian agriculture. The management accepted the survey report and decided to propose to the ICFA Board for converting it into a chamber and renaming it as the Indian Chamber of Food and Agriculture. After the Board approval, necessary clearances and legal paperwork to be completed. The formal launch was proposed for Dec 23 on the Farmers Day.

COLLABORATIONS/MEMORAN-DUMS OF UNDERSTANDING (MOUS)

ICFA with a view to build a reliable, valuable and rational relationship and to establish friendly and cordial relations between India and other countries signed Memorandum of Understanding with various organizations, including Universities. ICFA has entered into collaborations with organisations across the globe, till previous year ICFA had 16 active collaborations.

Agricultural & Processed Food Products Export Development Authority

Date: 04-03-2020



An MoU was signed with APEDA in New Delhi to work towards realizing the PM's vision of Doubling Agri Exports. Both organizations would work together in bringing better value to the stakeholders and work with the States in improving produce quality, preparing export basket, and promoting commodity specific value chain and GAP certification to boost agro trade. The MoU was signed by DG ICFA Mr. Pravin Srivastav and Chairman, APEDA Mr. Paban Borthakur.

Câmara de Comércio Índia Brasil (India Brazil Chamber of Commerce)

Date: 21-02-2020



An association was made with Câmara de Comércio Índia Brasil | India Brazil Chamber of Commerce by signing an MOU to provide networking platform that offers technological awareness, sharing of best practices and exploring untapped business potential in both the countries. IBCC objective is to enhance trade relations between two countries, and partnership with ICFA will further strengthen bilateral trade of agro and food sector in their respective target markets.

Tashkent State Agrarian University

A collaboration was entered with TSAU to promote education and training in IT, digital agriculture and agribusiness management. The MoU was signed between ICFA Chairman, Dr. MJ Khan and TSAU Rector, Dr. BA Sulaymonov. TSAU is the sole agriculture university in Uzbekistan with 3 campuses and 14,000 intake in different branches of agriculture. All universities in the country are state funded and the only private sector university has been set up by an Indian group, Sharda University. A high level meeting was held with the Ministry of Agriculture to create a joint working group for promoting agro trade and investments and encourage Indian companies to set up businesses for agri inputs, bio products, farm machinery, food, agribusinesses and animal health products, capacity building and agro produce certification.

Baker Tilly

An MoU was signed with Baker Tilly, UK for IT and contents services in agriculture and onboarding Baker Tilly as Technology Partner in FarmerPlus project being launched by ICFA in five districts of Karnal and Ambala in Haryana, Muzaffarnagar and Bulandshahr in UP and Alwar in Rajasthan. FarmerPlus project has been designed as a comprehensive support platform for farmers, involving over a dozen industry and institutional partners; to work on the target of doubling farm incomes.
