The food sector in KSA is set to grow at an impressive rate of 11.37%. India is also the largest food sourcing country for Saudi. KSA is also now focussing on agriculture, and for which India makes best country for providing inputs, technologies and expertise.

This collaborative initiative between India and KSA promises a bright future for the agri-food industry of India.
